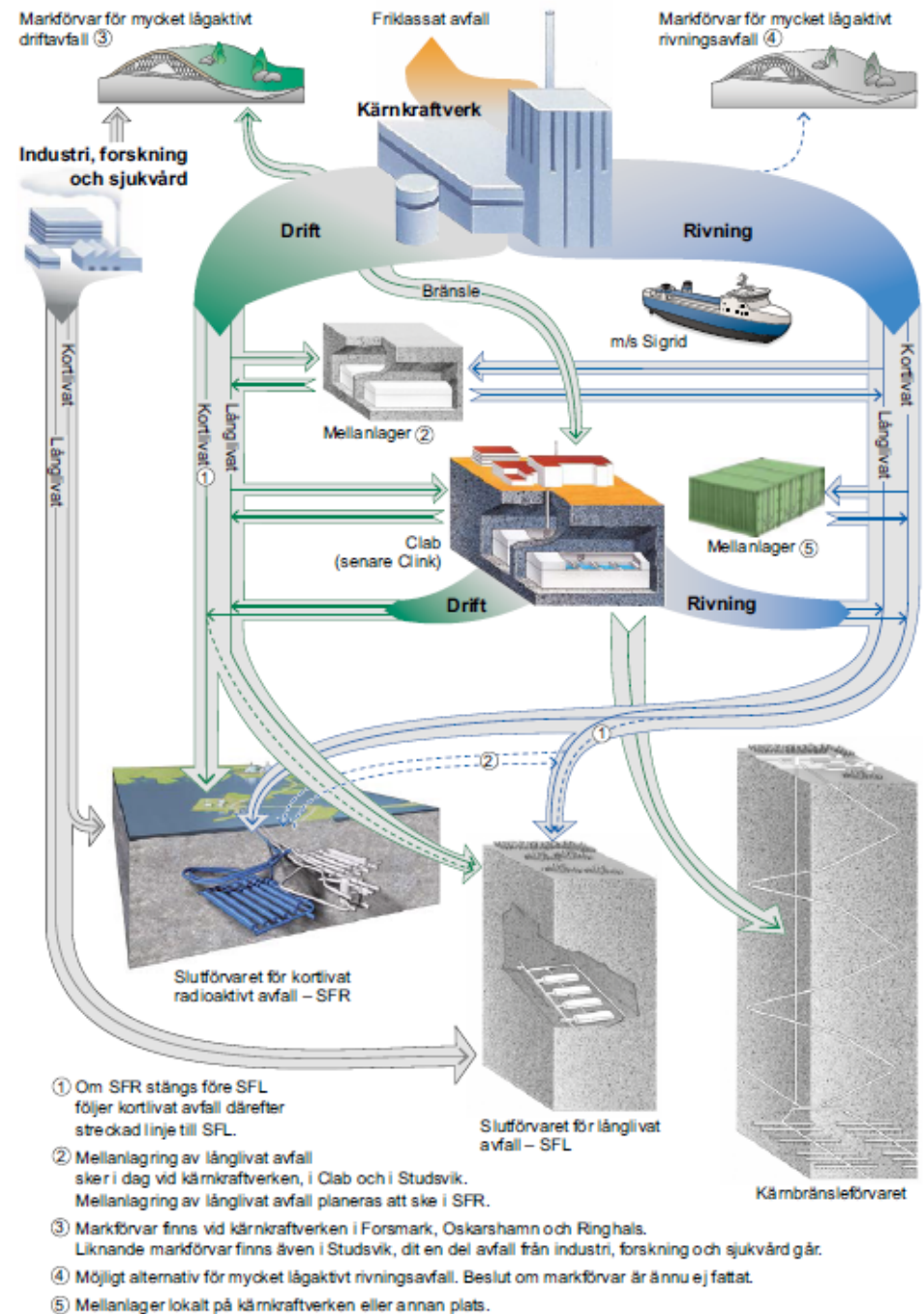

“... the Swedish government is in the process of deciding about a repository for final disposal of spent nuclear fuel to last 100 000 years.

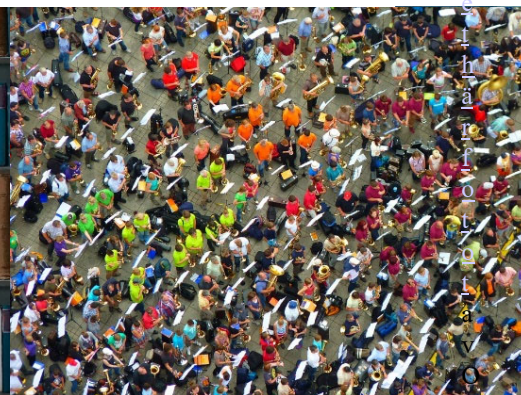
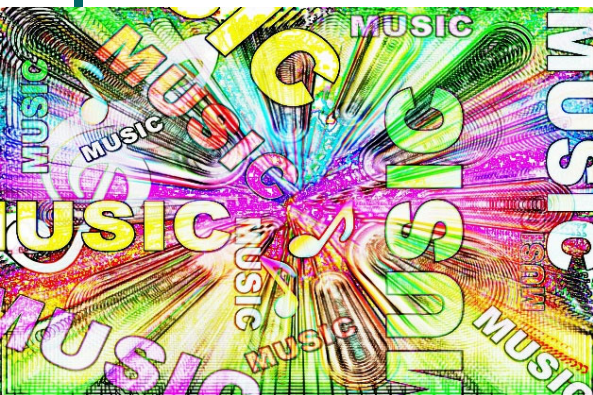
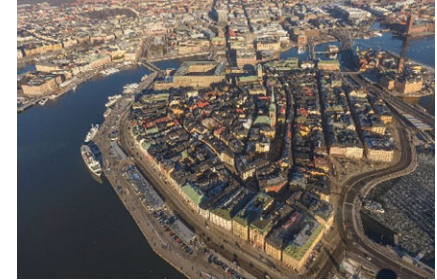
A similar, deep underground repository for the indefinite isolation of mercury-tainted and other processing waste is slated to be operating shortly.”
